Overview of terms and programs

Independent Charitable Organizations: Foundations are third-party independent 501(c)(3) organizations. Patients must meet diagnosis and coverage criteria to be eligible.¹

Medicare Extra Help (Low-Income Subsidy): Any individual who has enrolled in Medicare is eligible for Medicare prescription drug coverage. Some people with limited resources and income may also be able to get Extra Help to pay for the costs — monthly premiums, annual deductibles, and prescription copayments — related to a Medicare prescription drug plan.²

Medicare Savings Programs: State assistance for eligible patients with paying Medicare premium, deductible, coinsurance, and copayments. Available programs include the Qualified Medicare Beneficiary (QMB) Program, Specified Low-Income Medicare Beneficiary (SLMB) Program, Qualifying Individual (QI) Program, and Qualified Disabled and Working Individuals (QDWI) Program.³

State Pharmaceutical Assistance Programs: States may offer assistance in covering drug plan premiums and/or other drug costs. Eligibility may be based on financial need, age, or medical condition, and benefits may vary between programs.⁴

VA and/or TRICARE: VA medical benefits are provided by the United States Department of Veterans Affairs to retired or honorably discharged veterans who have served in the US Armed Forces. TRICARE is a government-provided insurance plan for active duty service members, National Guard/reserve members, and their families when services cannot be provided at a military treatment facility. Military retirees and their families also are eligible for TRICARE.^{5,6}
